4. Program Financial Support

- **b.** 2014 Balance Statement
 - i. Review funds in account- Dr. Yoder went over the current financial situation, along with the operating costs for each event. It was noted that overall, we are in good standing with finances, however one or two bad years with the horse show could change that. Dr. Yoder suggested engaging the Ag Foundation. This would take a lot of pressure off of future concerns of funds for the program.
 - Dr. Yoder suggested that we form a committee to look into using the foundation. This committee will consist of Pam Holland, Matt

Downs, and Lissy Newton. Sonya Murphy will be the contact with the University.

- 2. The statement showed the following in each account:
 - a. Account 1- \$11,559
 - b. Account 2- \$28,186
 - c. Account 3- \$80,059
 - d. Account 4- \$33,635 (\$105,658 total, some of which is livestock), this is where the enrollment money is housed
- ii. Emergency fund report-
 - Because of Candace Norman's health, Nan has been handling the Emergency Fund. Bill Crouse and Lissy Newton agreed to take it over and will have that account responsibilities transferred to their names.
- iii. Enrollment Fee- Ann Furr gave a report on the enrollment fee.
 - 1. There was discussion on whether or not to continue the enrollment fee. It was agreed that we need to continue to charge the fee, rather than charge for individual contests. There was an opinion expressed that the fee was a good thing and that it encouraged more participation in more contests. There was a suggestion made that the program is updated so that agents have lists and can check the list to see who has paid, rather than using cards. There was discussion on whether enrollment card and eligibility card should be combined, however it was decided this would not work due to non-showing members.
 - Discussion was had on the ways in which the money is spent.
 Some showed interest in having more money distributed to
 districts to be used at district events. Others wanted to see money
 used to help 4H'ers travel to National contests.

- Laura Harper made a motion to continue to charge \$25 dollars per youth or \$40 per family for enrollment in the Horse 4-H Program.
 The motion was seconded by Pam Holland, went to vote, and passed.
- A motion was made by Carrie Everhart that a portion of the money go back to each district on an annual basis. The motion was seconded, called to question, but did not pass.

b. Southern Regional Report

- Florida will host in 2015, in Perry, Georgia. The show dates are July 29-August 2. The show will be held in Perry, GA for 3-5 years and hosted by rotating states.

- iii. The Educational contest schedule will be the same as previous years, but the starting day will be Wednesday, instead of Tuesday.
- iv. Southern Regionals this year made about \$34,000, which will be returned to the region.

c. State Show Report

Lori Stroud shared an entry summary report for the 2014 show. Total entries were 1966, which was up from 1897 in 2013. The total number of horses was 313, which was up from 293 in 2013.

Her report included that entries for 2014 were 108, up from 97 in 2013. She also suggested that test names and years be included in the class list for Combined Training, in future years.

After Mary's report was reviewed, a discussion was had over updating rules. A motion was made by Debbie Hollowell to update rules to the appropriate association for each division (USEA, USDF, TWHBEA, or

USEF). The motion was seconded by Wanda Bunn, went to vote, and passed. A committee was formed in order to help revise the existing dressage rules and materials.

Dr. Yoder is consulting with the legal team at the University to determine the appropriate action to be taken in the cases of the positive tests.
- 2. Random drug testing will be continued at the State 4H Horse Show, and will follow the rules set forth in the Rule Book.

b. Show Classes, Rules, and Schedule Suggestions (Lori Stroud)

i. Bridle Path Hack will be added for Short Stirrup for points and qualifying

at the State Horse Show and District Horse Shows.

ii. Patterns will be offered on the website at least one week before the start

of the show. These will not include any over fences courses.

iii. Non-trotting patterns will state primary gait, secondary gait. This was

noted in the 2011 minutes, but seems to have not been changed in the

Rule Book.

iv. Short Stirrup Hunter Hack will be added for points and qualifying at the

State Horse Show and District Horse Shows.

v. "Equitation" will be included in the Rule Book when referring to the USEF

sections pertaining to Hunter divisions.

vi. Minimum fence heights will be added to the Rule Book. They will be as

listed:

1. Junior Horse: 2'9"-3'

2. Senior Horse: 2'9"-3'

3. Short Stirrup: 2'

4. Small Pony: 2'

5. Medium Pony: 2'- 2'3"

6. Large Pony: 2'3- 2'6"

7. Restricted Horses: 2'-2'3"

8. Restricted Ponies: 2'

- vii. Data will be collected at the 2015 State Show in order to determine if there is a more appropriate prize for Division Champion awards.
- viii. Scores for trail will be posted in the show office. Flip charts will be used for scored classes, as long as volunteers are ready and willing to operate them.
- ix. Little Britches Trail will be added and count for points and qualifying for the State Horse Show and District Horse Shows. The class will take place after Stock-Type Hunter Under Saddle on Friday.
- x. Western Pony Trail will be added for points at the State Horse Show. Entries will not be allowed to cross-enter into any other trail class.
- xi. Cloverbuds will be allowed to show at the State Horse Show in Cloverbud classes. Debbie Hollowell made a motion to allow Cloverbuds to show at the State Horse Show in Cloverbud Showmanship, Cloverbud Equitation, and Cloverbud Pleasure. Wanda Bunn seconded the motion, it was called to question, and passed.
- xii. Ranch Horse classes will be added at the State Horse Show. For the first year, Ranch Riding and Ranch Horse Trail will be added to the class list in July. We will follow Southern Regional Rules for the class descriptions and requirements. These will be invitational to any youth with an eligibility card. These classes are optional for District Horse Shows.

 There will not be a division award for these classes, but they will be considered for spots in the Southern Regional Delegation. The board will revisit the idea of adding cattle classes, possibly in conjunction with the Tarheel Triple Classic Horse Show, at next year's advisory board meeting. Joyce Bohn made a motion to add Ranch Riding and Ranch Horse Trail to

the State Horse Show in July as invitational, non-point classes. Matt Downs seconded the motion, it was called to question, and passed.

10. Educational Contest Evaluation and Future Recommendations:

- a. Horse Leader Training
 - i. There will be an emphasis on the new curriculum in 2015. Dr Yoder is looking into making some changes in his new position. Changes discussed included new topics, bringing back recognition of new leaders, and more training for agents that are not horse oriented.

b. Horse Camp

 - Change wording from "only one entry per participant is permitted" to "Only one entry per participant is permitted per contest category".
 - 2. In drawing, add "Captions are not permitted on the front of the drawing, and if used will be penalized."

- 3. In drawing, change "drawing entries are not to be framed", to "entries with frames will be disqualified."
- 4. In sewing, add "Participants must have used a thread with an eyed needle to join or attach fabric pieces together with stitches. Items such as needlepoint, knitting, weaving, macrame, etc belong in the craft category."
- 5. "Digitally Enhanced Photography" is renamed "Photography with Computer Enhanced Imagery".
- 6. In Horse Poster, remove "Entries failing to conform to contest rules will be disqualified."
- 7. In Painting, replace "Entries should not have captions", with "Captions are not permitted on the front of the painting and if used will be penalized."
- e. Horse Judging- The date of the contest is April 25 and the location is yet to be determined.
 - i. The State FFA Contest will be held in conjunction with our contest.
 - ii. Debbie Barham will announce at the contest.
 - iii. Laura Harper will volunteer, and bring parents to volunteer.
 - iv. Angela Kaus and Matt Downs will be in tabulations.

f. Horse Bowl

- i. Contest location will be at the NC State Campus.
- ii. Lissy Newton made a motion to update the reference list, to be put into effect in 2016. Matt Downs seconded, the motion was called to question, and passed. 2016 Reference list will be changed to use:
 - Illustrated Dictionary of Equine Terms rather than Look It Up (Junior Division)
 - 2. How to be Your Own Vet will no longer be a reference.
 - 3. Youth Leaders Manual will be added to the junior reference list.

iii. Wanda Bunn made a motion to only take two teams from each division,from each district, rather than the 14 that the rulebook currently accepts.Laura Harper seconded the motion. The motion was called to question,but did not pass.

g. Hippology

- There will be four classes to be judged for the judging portion. These will take place at the State Judging Contest.
- 11. Debbie Hollowell made a motion to hold the next Advisory Board Meeting November 13, 2015. The motion was seconded by Kristen Kaus, voted on, and passed.
